

VISITORS POLICY

PURPOSE

To provide a safe and secure learning and teaching environment for students and staff by establishing processes to monitor and manage visitors to Armstrong Creek School.

SCOPE

This policy applies to any visitors who may attend school grounds when the school is open for instruction between the hours of 8:40 and 3:30 pm including parents, contractors, NDIS therapists and Pre-Service teachers. Outside of these times, our front office is not staffed and the only visitors who are permitted on school grounds are parents/carers or their delegates who are dropping off or picking up students from YMCA, school events such as parent teacher interviews, concerts, sport or other school activities, and community and other groups who have entered into contracts or agreements with the school to use school premises outside of school hours.

DEFINITIONS

Child-related work: As defined by the Working with Children Act 2005 (Vic), child-related work is work that usually involves direct contact (including in person, over the phone, written and online communication) with a child that is a central part of that person's duties. It does not include work that involves occasional contact with children that is incidental to the work.

POLICY

Armstrong Creek School strives to create an open and inclusive school community, and encourages parents and carers to be actively involved in their child's development and education. We also strive to foster strong partnerships with local community services, schools and other organisations.

Armstrong Creek School is not a public place. The principal has the authority to permit or deny entry to school grounds, and encourages all visitors to familiarise themselves with our school's Statement of Values and School Philosophy, Child Safety and Wellbeing Policy, Child Safety Code of Conduct and Volunteer Policy.

From time to time, different members of the public may visit our school. Visitors may include, but are not limited to:

- Parents and carers
- Volunteers see our school's Volunteers Policy for more information
- Prospective parents, students and employees
- Invited speakers, sessional instructors and others addressing learning and development
- Public officials (e.g. Members of Parliament, local councillors)
- Persons conducting business e.g. uniform suppliers, booksellers, official school photographers, commercial salespeople
- Tradespeople
- Children's services agencies

- Department of Families, Fairness and Hoursing workers
- Victoria Police
- Persons authorised to enter school premises (e.g. Worksafe inspectors, health officers etc)
- Other Department of Education and Training staff (including allied health staff) or contractors
- NDIS therapists or other allied health or health practitioners

Sign in procedure

All visitors to Armstrong Creek School are required to report to the school office on arrival. Visitors must:

- Record their name, date and time of visit and purpose of visit in the Compass Kiosk.
- Provide proof of identification to office staff upon request
- Produce their valid Working with Children Clearance where required by this policy (see below)
- Wear a visitor's lanyard at all times
- Follow instruction from school staff and abide by all relevant policies relating to appropriate conduct on school
 grounds including Child Safety Code of Conduct, Respect for School Staff Policy, Statement of Values Policy,
 DET Sexual Harassment Policy and DET Workplace Bullying Policy.
- Return to the office upon departure, sign out and return visitor's lanyard.

Armstrong Creek School will ensure that our school's Child Safety Code of Conduct is available to visitors when they sign in.

Working with Children Clearance and other suitability Clearances

For Working with Children Clearance (WWC Clearance) and other suitability Clearance requirements relating to parents/carers and other volunteers working with students please see our Volunteers Policy (available via our website).

Schools have the discretion to decide which visitors, if any, will be required to have a WWC Clearance above the legal minimum set out in the *Working with Children Act 2005* (Vic). This Act legally requires all people engaged in 'child-related' work (see definition on this template), to hold a WWCC. The Department has a useful flowchart to assist schools in relation to making decisions about suitability Clearances:

All visitors who are engaged in **child-related work** (see definition above) must have a valid WWC Clearance. Additional suitability Clearances may also be required such as reference, proof of identity, qualification and work history involving children Clearances.

In some circumstances, visitors to Armstrong Creek School who are **not** engaged in child-related work will also be required to produce a valid WWC Clearance depending on the particular circumstances of their visit. For example, Armstrong Creek School will require a valid WWC Clearance for:

- **visitors who will be working regularly with children** during the time they are visiting, even though direct contact with children is not a central part of their normal duties
- **visitors (e.g. contractors)**, who will regularly be performing work at the school and in circumstances where they will be performing their work in an area where they will be unsupervised and around children. Further background Clearances, including references, may also be requested at the discretion of the principal.

Visitors who will be working in areas away from students (e.g. a visiting auditor who will be located in the front office with administration staff) or who will be supervised and accompanied by a staff member during their visit (e.g. a Member of Parliament, a journalist, a prospective parent on a school tour) will not be required to have a WWC Clearance.

Sworn Victoria Police officers or sworn Australian Federal Police officers are exempt from requiring a WWC Check but may be asked to verify that they are sworn officers by providing proof of identification.

Invited speakers and presenters

On occasion, Armstrong Creek School may invite external speakers or providers to deliver incursions, presentations, workshops and special programs for our students. Consistent with Department of Education and Training requirements, Armstrong Creek School will:

- ensure that the content of presentations and programs by external providers contributes to the educational development of our students and is consistent with curriculum objectives
- ensure that any proposed visit, programs or content delivered by visitors complies with the requirement that
 education in Victorian government schools is secular and is consistent with the values of public education,
 Department policies and the Education and Training Reform Act 2006 (Vic). In particular, programs delivered
 by visitors are to be delivered in a manner that supports and promotes the principles and practice of Australian
 democracy including a commitment to:
 - o elected government
 - o the rule of law
 - o equal rights for all before the law
 - o freedom of religion, speech and association
 - o the values of openness and tolerance
 - o respect the range of views held by students and their families.

Parent visitors

We understand that there may occasionally be a reason why a parent or carer may want to speak to or see their child at school, during school hours.

If there is a particular pressing or unavoidable issue that cannot wait until the end of the school day, we ask that parents or carers call the school office to make the request to speak to or see their child during school hours.

We also ask that parents avoid arranging to visit their children at school wherever possible, as this can cause inappropriate disruptions to the school day.

All parents or carers who visit our school during school hours, other than for the purposes of school pick-ups and drop offs or for specific school events (parent teacher interviews, concerts, assemblies etc), are required to sign in as a visitor at the school office.

Other visitors

All business operators, tradespeople and other visitors attending the school to conduct work must report to the school office upon arrival for instruction and follow the sign in procedure outlined above.

COMMUNICATION

This policy will be communicated to our school community in the following ways:

- Available publicly on our school's website and via Compass for parents, carers, students and staff
- Included in staff induction processes and annual staff training
- Included in staff induction processes
- Included in our staff handbook/manual
- Discussed at staff meetings and professional learning session as required
